## JOURNAL ENTRY

- 1. On December 6, 2007, a Journal Entry was filed cancelling the license of Licensee for failure to have met the requirements for renewal as specified in a Summary Order of Cancellation of License filed November 14, 2007.
- 2. On December 12, 2007, Licensee filed an application for reinstatement, provided the proof of continuing education and of professional liability insurance necessary to meet the requirements for the renewal period and for reinstatement, and paid the reinstatement fee of \$300 and his license was reinstated effective that date.,
- 3. At the time Licensee submitted his application for reinstatement, Licensee also submitted a Reinstatement of Cancelled License form in which he requested that the reinstatement be made retroactively effective back to December 6, 2007.

4. In accordance with Board Policy Statement No. 04-01, Licensee's request for retroactive reinstatement of license should be granted and the status of Licensee's license should be modified and retroactively reinstated on active status from and since December
