Having the agency record before it the Board adopts as its Final Order the findings, conclusions and order stated in the Initial Order, which dismisses Counts 1-11, Count 12 to the extent that it alleges Respondent unlawfully invaded the practice of chiropractic, and Count 13. The Board takes note that Petitioner dismisses the remainder of Count 12.


IT IS, THEREFORE ORDERED that the Petition is denied.
