**FINAL ORDER TERMINATING CONSENT ORDER**

NOW on this 10th day of June, 2016, comes before the Kansas State Board of Healing Arts (“Board”) the request of Daniel Frye, MD (“Licensee”) for termination of his Consent Order filed on February 24, 2009. Licensee appears in person and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.


Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving evidence, and being otherwise advised in the premises, the Board makes the following findings, conclusions and order:

1. On February 24, 2009, Licensee entered into a Consent Order as a condition of reinstatement of his medical license which had been canceled by operation of law due to his failure to renew it in 2008.
2. On January 14, 2016, Licensee submitted a request to the Board for termination of the Consent Order.
3. On March 8, 2016, Associate Litigation Counsel filed a Response to Petition for Termination of the Consent Order and submitted exhibits in support. The Response opposed termination of the Consent Order.

4. Licensee presented evidence and testimony substantially rebutting the Response.
5. The Board finds that the evidence presented by Associate Litigation Counsel is insufficient to demonstrate grounds for denying Licensee's Request to Terminate the Consent Order.
6. The Board finds that Licensee has satisfactorily met all requirements of the Consent Order and concludes that termination of the Consent Order is warranted in the circumstances.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that the Consent Order filed on February 24, 2009, is hereby **TERMINATED** and that Licensee shall have no further obligation for compliance.

Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order.
