## SUMMARY ORDER DENYING APPLICATION FOR CERTIFICATION

NOW, on this 15 day of July, 1998, this matter comes before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board") in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and orders are made for and on behalf of the Board.

- 1) On or about April 28, 1997, Sunday Varquez Galias (hereafter "Applicant") filed an Application for Registration as a Physical Therapist to practice physical therapy in the State of Kansas.
- 2) On August 7, 1997 Applicant was advised his application was incomplete because he had not provided his grade point average from his physical therapy school. On December 11, 1997, Applicant was again notified his application was not complete.
- 3) Applicant has failed to complete the application as required by K.S.A. 1997 Supp. 65-2906.

IT IS THEREFORE ORDERED AND DECREED for and on behalf of the Board as follows:

- a) That, pursuant to K.S.A. 1997 Supp. 65-2906, Applicant has not completed the requirements provided for in this act for registration as a physical therapist in the State of Kansas.
- b) Applicant's Application for Registration as a Physical Therapist received by the Board on April 28, 1997 be **DENIED**.
- c) This is a Summary Order and either party is entitled to a review if a written request of received in the Board office within 15 days of service of the Order upon the parties. If no request is received, this Order will become immediately effective.
