FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW on this 5th day of February, 1994, comes on for Conference Hearing before the Kansas State Board of Healing Arts ("Board") sitting as a whole the application for reinstatement filed by Glenn M. Gardner, M.D. ("Applicant"). Gretchen E. Schmidt, Staff Counsel for the Board, appears on behalf of the Board. Applicant does not appear.

After reviewing the application and being otherwise duly advised in the premises, the Board makes the following findings of fact and order:

- 1. Applicant was originally licensed to practice medicine and surgery in the State of Kansas on June 5, 1971.
- 2. Applicant's license was cancelled on August 17, 1992 due to his failure to renew said license.
- 3. Applicant filed an application for reinstatement with the Board on January 28, 1993.
- 4. Applicant's application raised questions as to Applicant's physical ability to practice medicine and surgery. Applicant's application was forwarded for Board legal review on

April 5, 1993.

- 5. Letters dated April 30, 1993 and August 20, 1993 from Board legal staff to Applicant requested additional information pertaining to Applicant's accident and hospitalization. Such letters were sent to the last known mailing address provided by Applicant to the Board. No response to these communications has been received in the Board office. Such letters further informed Applicant that failure to reply to this request for information would result in the presentation of his application for reinstatement to the Board in its incomplete state.
- 6. A Notice of Conference Hearing on his application for reinstatement was mailed to Applicant at the last known mailing address provided by Applicant to the Board.
- 7. K.S.A. 65-2809 provides that a license which has been cancelled for failure to renew may be reinstated only upon recommendation by the Board.
- IT IS THEREFORE ORDERED BY THE BOARD that Applicant's application for reinstatement of license should be deemed incomplete.
- IT IS FURTHER ORDERED that Applicant's application for reinstatement of license should be denied.
- IT IS FURTHER ORDERED that Applicant should be required to comply with the requirements necessary in order to reinstate his license to practice medicine and surgery in the State of Kansas.
 - IT IS FURTHER ORDERED that this is a Final Order and is

effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
