**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 23<sup>rd</sup> day of April, 2005, comes on for Conference Hearing before the Kansas State Board of Healing Arts ("Board"), the Application for Status Change filed by Patrick Garrett, D.C. ("Licensee").

Charlene K. Abbott, Licensing Administrator, presented information before the Board. Applicant appeared in person *pro se*.

After reviewing the file, hearing the statements of Ms. Abbott and Applicant and being otherwise duly advised in the premises, the Board finds as follows:

1. Licensee was originally issued License number 01-04819 to practice chiropractic in the state of Kansas on April 26, 2003.
2. On January 3, 2005, as part of the renewal process for the license period January 1, 2005 through December 31, 2005, Licensee requested that his license be placed in inactive status.
3. On or about February 8, 2005, Licensee filed an Application for Status Change to change his license from inactive to active status.
4. To qualify to change his license from inactive to active, Licensee is required to provide proof satisfactory to the Board of completion of minimum of 50 hours of continuing education in the past one year.


5. As part of his Application for Status Change, Licensee provided a syllabus for courses in the third and fourth year curriculum required by the University of Health Sciences Antigua and other information regarding the rotations and course work Licensee has completed in the past year.

6. The course work and rotations completed by Licensee during the past year meet the continuing education requirements for Licensee to change his licensure status from inactive to active.

**IT IS THEREFORE ORDERED** that the above findings are made the order of the Board and that Licensee's Application for Status Change of his license from inactive to active is granted.


