SUMMARY ORDER

NOW ON THIS 17th day of March, 2014, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A 77-537.

Pursuant to K.S.A 77-542, this Summary Order shall become effective as a Final Order, without further notice, if no written request for hearing is made within fifteen (15) days of service.

Upon review of the agency record and being duly advised in the premises, the following findings of fact, conclusions of law, and order are made for and on behalf of the Board:

Findings of Fact

1. Laurence Gaynor, M.D. ("Licensee") was originally issued license number 04-20278 to practice medicine and surgery in the state of Kansas on December 9, 1983. Licensee's current license designation is active, and such license was last renewed on or about June 30, 2013.
2. Licensee's last known mailing address to the Board is: 10700 E. Geddes Avenue, Suite 200, Englewood, Colorado, 80112.
3. On or about June 12, 2013 the Kansas Board of Healing Arts received a

Federation of State Medical Boards Disciplinary Report that indicated the Colorado Medical

Board had admonished Licensee in a formal letter on May 15, 2013 for failure to conform to the minimal standards of acceptable medical practice.

4. Licensee's admonishment was based on his failure to identify a zygomatic arch fracture on February 28, 2010 at Porter Adventist Hospital in Denver, Colorado.

5. Licensee filed an application to renew his Kansas license on May 22, 2013. Licensee was asked on his application whether or not he had been subject to discipline by any other entities and he answered "no".

6. All pending investigation materials regarding Licensee were fully reviewed and considered by the Board's Disciplinary Panel # 28. The Disciplinary Panel authorized and directed the issuance of this Summary Order and the specific disciplinary sanctions.

Applicable Law

7. K.S.A. 65-2836 of the Kansas Healing Arts Act states in pertinent part:

A licensee's license may be revoked, suspended or limited, or the licensee may be publicly or privately censured or placed under probationary conditions, or an application for a license or for reinstatement of a license may be denied upon a finding of the existence of any of the following grounds:

- (a) That licensee has committed a fraud or misrepresentation in applying for or securing an original, renewal, or reinstated license.
- (j) That licensee has had a license to practice the healing arts revoked, suspended, has been censured, or has had other disciplinary action taken or an application for a license denied, by the proper licensing authority of another state, territory, District of Colombia, or other country, a certified copy of the record of the action of the other jurisdiction being conclusive evidence thereof.

Conclusions of Law

8. The Board finds that Licensee violated K.S.A. 65-2836(a) when he failed to notify the Board when he filed his application for renewal of his State of Kansas license to practice medicine and surgery on May 22, 2013, of the action taken against his Colorado license by the Colorado Medical Board.

9. The Board finds that Licensee violated K.S.A. 65-2836(j) when he was admonished by the Colorado Medical Board on May 15, 2013.


10. Based on the facts and circumstances set forth herein, the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a) in that the use of summary proceedings does not violate any provision of law and the protection of the public interest does not require the Board to give notice and opportunity to participate to person other than Licensee.

IT IS, THEREFORE, ORDERED that Licensee is **PUBLICLY CENSURED** for violating K.S.A. 65-2836(a) and K.S.A. 65-2836(j) of the Kansas Healing Arts Act.

PLEASE TAKE NOTICE that upon becoming effective as a Final Order, this document shall be deemed a public record and be reported to any reporting entities authorized to receive such disclosure.
