SUMMARY ORDER

NOW, on this 9th day of December, 1994, comes on for summary proceedings before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole the application of Mohammad Ghassemi, M.D. (hereafter "Applicant") for licensure to practice medicine and surgery in the State of Kansas.

Charlene K. Abbott, Licensing Administrator, appeared to present information to the Board. Applicant appeared pro se. There are no other appearances.

After reviewing the files and being duly advised in the premises, the Board makes the following findings of facts, conclusions of law and order:

1. Applicant has heretofore filed an Application for Endorsement to receive a license to practice medicine and surgery in the State of Kansas.

2. K.S.A. 65-2873 provides that a person cannot be licensed under that statute unless the school from which they graduated has been in existence for more than fifteen (15) years.

SUMMARY ORDER

3. In the application filed herein, Applicant indicated and provided evidence that he is a graduate of Universidad Eugenio Maria De Hostos Uniremhos, Santo Domingo, Dominican Republic.

4. According to the World Health Organization Directory, Universidad Eugenio Maria De Hostos Uniremhos commenced instruction in 1981.

5. Information provided by Applicant, indicates he has a license to practice medicine and surgery in the State of Missouri.

6. Pursuant to the provisions of K.S.A. 65-2833, Applicant meets the requirements to receive a license by endorsement based upon the license to practice medicine and surgery in the State of Missouri.

IT IS THEREFORE BY THE BOARD ORDERED that Applicant meets the requirements of K.S.A. 65-2833 to receive a license to practice medicine and surgery in the State of Kansas by endorsement based upon the Missouri license issued to him.

Applicant is entitled to an administrative review of this Order if a written request is received in the Board office within fifteen (15) days of the service of this Order upon Applicant.

IT IS SO ORDERED.
