## SUMMARY ORDER DENYING APPLICATION FOR REGISTRATION

NOW, on this  $10^{71}$  day of February, 1997, this matter comes before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board") in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, following findings of fact, conclusions of law and orders are made for and on behalf of the Board.

1) On or about June 3, 1996, Stanley L. Gibson (hereafter "Applicant") filed an Application For Registration As A Physical Therapist to practice physical therapy in the State of Kansas.

2) In response to item number 14 (Certificate of Physical Therapist School) on the application, Applicant provided the Board with a US Army Diploma indicating successful completion of the Physical Therapy Specialist Course from the Academy of Health Sciences given at Fort Sam Houston, Texas from April 25, 1994 to November 9, 1994.

3) Pursuant to K.S.A. 65-2906, Applicant must have graduated from a school of physical therapy approved by the Board. The Academy of Health Sciences at Fort Sam Houston, Texas is not an approved school of physical therapy.

4) Applicant currently holds temporary permit no. 9720932 issued on September12, 1996 and which will expire on February 15, 1997.

IT IS THEREFORE ORDERED AND DECREED for and on behalf of the Board as follows:

a) That, pursuant to K.S.A. 65-2906, Applicant has not successfully met the requirements provided for in this act for registration as a physical therapist in the State of Kansas.

b) Applicant's Application For Registration As A Physical Therapist received by the Board on June 3, 1996 be DENIED.

c) This is a Summary Order and either party is entitled to a review of the Order if a written request is received in the Board office within 15 days of service of the Order upon the parties and if no request is received, this Order will become immediately effective.
