FINAL ORDER TERMINATING MONITORING

NOW on this 11th day of April, 2014, comes before the Kansas State Board of Healing Arts (“Board”) the request of Dana Gifford, PTA (“Licensee”) for termination of the monitoring requirement contained in the Final Order filed on December 15, 2009. Licensee appears in person and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2901 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is presently licensed to engage in the practice of Physical Therapy Assistant in the State of Kansas, having been issued License No. 14-01066.

10. On or about January 27, 2014, Licensee submitted a request for the termination of the monitoring provisions of the Final Order.



PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service, and service of a Final Order is complete upon mailing. Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
