SUMMARY ORDER CANCELLING TEMPORARY REGISTRATION

NOW, on this 17th day of March, 1995, this matter comes on for consideration before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board") sitting as a Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 77-538, the second temporary registration issued to Josphat W. Gikonyo (hereafter "Applicant"). There were no appearances.

After reviewing the request and being otherwise duly advised in the premises, the Presiding Officer finds as follows:

1. Applicant was granted a temporary registration on January 5, 1994 which expired on January 5, 1995.
2. At the meeting of the entire Board which was held February 11, 1995, Applicant was granted a second temporary registration from February 11, 1995 for a period of two (2) months or until the results of the January 28, 1995 AOTCB examination became available to the Board, whichever event should occur first.
3. On March 6, 1995, the Board office received the results from the AOTCB examination conducted January 28, 1995 which reflected Applicant failed to pass such examination.

4. Based upon action taken by the Board at its meeting on February 11, 1995, the temporary registration 9501885 issued to Applicant on February 11, 1995, should be cancelled on the effective date of this Order.

IT IS THEREFORE ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That the second temporary registration no. 9501885 issued to Applicant should be cancelled on the date this Order becomes effective.

C. Applicant is entitled to request a hearing on this Order, in writing, addressed to the Kansas State Board of Healing Arts, 235 S. Topeka Boulevard, Topeka, Kansas 66603-3068 within seven (7) days of service of this Order and if a hearing is not requested within the time and manner above stated, the cancellation of the temporary registration becomes final and effective upon the expiration of the time for requesting a hearing.

IT IS SO ORDERED.
