## FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 11th day of February, 1995, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the request submitted by Josphat W. Gikonyo (hereafter "Applicant") for request for a second temporary registration. Charlene K. Abbott, Licensing Administrator, presented information to the Board regarding Applicant's request. There were no other appearances.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

- 1. Applicant was granted a temporary registration on January 5, 1994 and which expired on January 5, 1995.
- 2. A request for a second temporary registration was received from the Applicant on January 6, 1995.
- 3. Applicant has taken the American Occupational Therapy Certification Board (AOTCB) examination required and approved by the board for registration as an occupational therapist

on January 28, 1995, but the results of that examination were not available to Board staff at the time of the February 11, 1995 Board Meeting.

## IT IS THEREFORE ORDERED as follows:

- A. That the findings here and above made be and the same are made the Order of the Board.
- B. Pursuant to K.S.A. 65-5408(d) Applicant is granted a second temporary registration for a period of two (2) months from the date of the February 11, 1995 Board Meeting or until the results of the January 28, 1995 AOTCB examination become available to the Board, whichever shall come first.
- C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service file a petition to review this order and file a Petition for Reconsideration. A Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
