
JOURNAL ENTRY OF SATISFACTION

NOW on this 8<sup>th</sup> day of August, 2012, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas Board of Healing Arts (“Board”), concerning Stephanie D. Gilkey-Nicol, D.C. (“Licensee”) satisfaction of requirements contained in the Consent Order filed with the Board on October 27, 2011. Wherefore, the Board finds as follows:

1. On or about October 27, 2011, a Consent Order was filed regarding Licensee’s license alleging that Licensee had violated K.S.A. 64-2836(b) as further defined by K.S.A. 65-2837(b)(2) and K.S.A. 65-2837(b)(8).
2. The Consent Order required Licensee to pay a civil fine of \$1500.00.
3. The Consent Order also placed Licensee’s license on probation until she successfully completed a continuing education course for chiropractic advertising. The Consent Order further stated that upon completion of the continuing education course, the term of probation shall terminate.
4. Licensee has paid the civil fine levied in this matter and has completed the requirements for continuing education.
5. Therefore the term of probation levied against Licensee’s license is hereby terminated.
