FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 14th day of February, 1998, this matter comes on for conference proceedings at the request of Charity Goben, (P.A.), (hereafter "Applicant") to grant a second temporary registration pursuant to K.S.A. 65-2896d,

Charlene K. Abbott, Licensing Administrator, presented information to the Kansas Board of Healing Arts (hereafter "Board"). Applicant appeared pro se.

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of facts, conclusions of law and order:

- 1) A January 8, 1998 request for a second temporary registration from Applicant was received in the Board office.

2) Notice of Conference Hearing setting this matter for hearing at 1:15 p.m. on Saturday, February 14, 1998, was filed herein on January 30, 1998 and mailed to Applicant on that same date.

3) Applicant has applied for permanent registration as a physician's assistant, but has not passed an exam approved by the Board as required by K.S.A. 65-2896a(a)(3).

4) Applicant was granted a temporary registration number, 9820327, which expired February 28, 1998.

5) Pursuant to K.S.A. 65-2898d, not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

6) Upon payment of the appropriate fees, Applicant should be granted a second temporary registration to expire June 13, 1998.

IT IS THEREFORE ORDERED as follows:

a. That upon payment of the appropriate fee, a second temporary registration be granted to Applicant to expire June 13, 1998.

b. That this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for

Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
