ORDER GRANTING THIRD TEMPORARY PERMIT

NOW, on this 29th day of April, 1995, this matter comes on for conference proceedings at the request of Nahid Golpagoon (hereafter "Permittee") to grant a third temporary permit pursuant to K.S.A. 1994 Supp. 65-2906(b)(3) and more specifically K.A.R. 100-36-1.

Charlene K. Abbott, Licensing Administrator, presented information to the Kansas Board of Healing Arts (hereafter "Board"). Permittee appears in person pro se. Candance Bahner, R.P.T., Physical Therapy Examining Committee, also appeared to provide information to the Board.

After hearing statements from the parties and Permittee and being duly advised in the premises, the Board makes the following findings of facts, conclusions of law and order:

1) A request for a third temporary permit was filed by Permittee on January 5, 1995.

2) An Order of Continuance and Notice of Conference Hearing was filed and mailed herein on February 17, 1995 to

Permittee setting this matter for hearing at 8:45 a.m. on April 29, 1995.

3) Permittee has applied for permanent registration as a physical therapy assistant, but has not passed an exam approved by the Board as required by K.S.A. 1994 Supp. 65-2906(b)(3).

4) Permittee was granted a second temporary permit number, 9500710, which will expire May 1, 1995.

5) Pursuant to K.A.R. 100-36-1, not more than two temporary permits shall be permitted to any one person without the majority approval of the members of the Board and for which good cause shall be shown.

6) It was determined by the Board that good cause has been provided in that Permittee is from Iran and may have difficulty understanding the English language in such a manner that her ability to fully comprehend the questions on the examination in the time period which was allowed may have contributed to her failure of the examination.

7) Upon payment of the appropriate fees, Permittee should be granted a third temporary permit which shall be valid until the occurrence of any one of the following:

- (a) Permittee, prior to September 15, 1995, provides proof of successful passage of the National Physical Therapy Assistant Examination (NPTAE), then the temporary permit will be cancelled on the date the Board issues a permanent registration to Permittee; or

(b) Permittee, prior to September 15, 1995, fails to provide proof of passage of the NPTAE, then the temporary permit will be cancelled and of no further force or effect.

**IT IS THEREFORE ORDERED** as follows:

a. That upon payment of the appropriate fee, a third temporary permit be granted to Permittee which will be valid until cancelled as provided in paragraph 7 above.

b. That this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

**IT IS SO ORDERED.**
