FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 26th day of April, 2008, comes on for conference hearing before the Kansas State Board of Healing Arts (“Board”) the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Robert Seth Gordon, M.D. (“Applicant”). Katy Lenahan, Licensing Administrator, provided information to the Board. Applicant appeared in person *pro se*.

After reviewing the file, hearing the information provided by Ms. Lenahan, the testimony of Applicant and being otherwise duly advised in the premises, the Board makes the following findings and orders.

1. On or about March 4, 2008, Applicant filed an Application for Licensure to practice medicine and surgery in the state of Kansas.
2. Information provided as part of the application indicates that Applicant passed Step 1 of USMLE on June 14, 1995, Step 2 on August 26, 1997 and Step 3 on April 20, 2007.
3. Applicant did not pass Step 3 of USMLE within the time limit established by K.A.R. 100-7-1(b)(1).

4. Applicant has been granted licenses to practice in Arizona, Delaware, Florida, New York, Wyoming, Massachusetts, and Maine.


5. Although Applicant did not pass Step 3 of USMLE within 10 years of passage of Step 1, Applicant meets the requirements of K.S.A.65-2833 for endorsement based upon his licensure in seven other states and passage of all steps of USMLE, which are the examinations required in this state.

IT IS THEREFORE ORDERED that Applicant is eligible for license by endorsement based upon his licensure in seven other states and his Application for Licensure should be granted effective April 26, 2008.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


