ORDER OF RETROACTIVE REINSTATEMENT OF LICENSE

NOW, on this 15th day of October, 1994, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, upon the request of Kenneth L. Grady, M.D. (hereafter "Licensee") for retroactive reinstatement of his license. Licensee did not appear.

1. Licensee was originally licensed to practice medicine and surgery in the State of Kansas on June 2, 1969.

2. Licensee last renewed his license for the period of July 1, 1993 through June 30, 1994 on July 22, 1993.

3. Licensee failed to renew his license for the period of July 1, 1994 through June 30, 1995 prior to the August 1, 1994 deadline.

4. This matter was commenced by the filing of a Notice of Hearing and consequently Licensee's license was cancelled at a Conference Hearing conducted by the Board at its meeting on August 13, 1994.

5. On September 1, 1994, Licensee provided a completed renewal form with appropriate fees and was granted an administrative reinstatement of his inactive license to practice medicine and surgery in the State of Kansas effective September 1, 1994.

6. A request for a retroactive reinstatement of Licensee's inactive license was requested from Licensee on September 1, 1994 for the period of August 15, 1994 to September 1, 1994.

7. On September 30, 1994, a Notice of Conference Hearing was filed and sent to Licensee giving him notice of a conference proceeding to be conducted at 1:30 p.m. on October 15, 1994 on the request for retroactive reinstatement of license 4-14440 for the period of August 15, 1994 to September 1, 1994.

8. On October 15, 1994, the Board met to consider Licensee's request for retroactive reinstatement of license from August 15, 1994 to September 1, 1994.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

A. That the findings here and above made be and the same are made the Order of the Board.

B. The status of the license of Licensee should be retroactively modified to reflect that Licensee was licensed in the inactive status to practice medicine and surgery in the State of Kansas from and after August 15, 1994. Said modification is subject to the condition precedent that Licensee pays the costs of this proceeding in the amount of fifty dollars (\$50).

C. The \$50 in costs are to be received in the Board office within thirty (30) days of service of this Order and if not so received, this Order shall be null and void and no retroactive modification to the licensure status of Licensee shall be made or become effective. Upon receipt of the costs in the Board office within thirty (30) days of service of this Order, the Board records will be modified to reflect that Licensee had an inactive license in the State of Kansas for the period of August 15, 1994 through September 1, 1994.

IT IS SO ORDERED.
