FINAL ORDER GRANTING MOTION TO STAY CONSENT ORDER

NOW this 14th day of June, 2019, comes on for conference hearing before the Kansas State Board of Healing Arts ("Board"), the Motion of Karl Grant, D.O. ("Licensee") to Stay Consent Order filed with the Board on May 31, 2013. Licensee appears in person, and through his counsel, Mark Stafford of Forbes Law Group, LLC. Nancy Dodik, Associate Disciplinary Counsel, appears on behalf of the Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, et seq., and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the agency record, hearing the arguments of the parties, hearing the testimony of Licensee, considering the admitted exhibits, and otherwise being duly advised in the premises, the Board grants Licensee's Motion to Stay the Consent Order. Licensee's license status shall immediately be changed from exempt to inactive. If Licensee requests a status change from inactive, attempts to reinstate his license if it is cancelled for failure to renew, or otherwise changes his license status in any manner that would permit the practice of medicine and surgery in Kansas, the Board may either lift the stay and impose the conditions stated

in the Consent Order, or may consider whether other conditions upon his license are appropriate at that time.

A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order.
