**MODIFICATION OF STIPULATION AND AGREEMENT AND

COMES NOW, the Kansas State Board of Healing Arts ("Board") sitting in conference hearing this 27th day of June, 1997, to consider the May 27, 1997, request of Michael D. Grant, M.D. ("Licensee") for modification to the April 7, 1997 Stipulation and Agreement and Enforcement Order ("Stipulation") between the Board and Licensee. The Board is represented by Kevin K. LaChance, Disciplinary Counsel. Licensee appears in person without counsel.

(Confidential) Finally, the Board notes the concerns raised by the representative for the Board regarding the necessity for monitoring of Licensee's prescribing of all prescription medications. The Board approves modification of the Stipulation as follows:

1. Paragraph 5(a)(i) is hereby terminated. Licensee's license is hereby placed in an Active status, subject to the normal requirements of Board licensees in maintaining Active status

2. Paragraph 5(a)(ii) is hereby terminated and replaced with the following:



3. Paragraph 5(a)(iv) is hereby terminated and replaced with the following:




