ORDER OF RETROACTIVE MODIFICATION TO LICENSE STATUS

NOW, on this 12th day of March, 1994, this matter comes on for consideration before the Kansas Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of Captain K. Gray, M.D. (hereafter "Licensee") for retroactive modification of license status.

Charlene K. Abbott, Licensing Administrator, appears on behalf of the Board. Licensee did not appear. There are no other appearances.

After reviewing the request and being otherwise duly advised in the premises, the following findings are made:

1) Licensee was originally licensed to practice medicine and surgery in the State of Kansas on August 9, 1976.

2) That on January 1, 1991, Licensee left the State of Kansas for further medical training in Illinois and did not reside in the State of Kansas from January 1, 1991 through April 15, 1991. During such period, Licensee did not actively engage in the

practice of medicine and surgery in the State of Kansas and met the qualifications for an exempt license.

3) That by misunderstanding, inadvertence or mistake, Licensee failed to make proper application to have his license placed on exempt status while he was outside the State of Kansas from January 1, 1991 through April 15, 1991.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

A. That the findings here and above made be and the same are made the order of the Board.

B. The status of the license of the Licensee, Captain K. Gray, M.D., to practice medicine and surgery in the State of Kansas should be retroactively modified to reflect that Licensee's license was placed on exempt status from January 1, 1991 through April 15, 1991.

C. This is a Final Order and is effective upon service on the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
