**JOURNAL ENTRY OF SATISFACTION
AND TERMINATION OF SUSPENSION**

NOW, on this 22^d day of December 2008, the above-entitled matter comes on before Jack Confer, Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On November 12, 2008, A Summary Order was filed in Docket No. 09-HA00074 which found that Licensee had violated K.S.A. 65-2836(r), assessed a civil penalty of \$500.00 and required that documented proof of compliance with continuing education requirements be submitted within fifteen (15) days of issuance of the Summary Order. The Summary Order stated that failure to comply with the terms of the Order would result in the suspension of the license to practice medicine and surgery in Kansas. Licensee failed to comply with the terms of the order.


2. On December 3, 2008, the license of William Greiner, M.D. (licensee) was suspended for failure to provide documented evidence of the minimum continuing education hours.

3. On December 16, 2008, licensee paid the \$500 fee and provided documented proof of completion of the minimum of hours of continuing education.

4. Licensee has fully satisfied the requirements set forth in the Summary Order filed November 12, 2008 by paying the \$500 civil penalty and providing documentation of completion of continuing education credits; therefore the Suspension of License imposed by the Summary Order filed November 12, 2008 is lifted, and no further action is required.
