**FINAL ORDER**

**NOW ON THIS** 2nd day of December, 2006, this matter comes before the Board to review the Initial Order issued December 22, 2005 by Presiding Officer Steven E. Good and to review additional evidence presented for the record by both Respondent and Petitioner. Isaac Grillo, M.D. ("Respondent") failed to appear and Kelli J. Stevens, Litigation Counsel appeared for the Board ("Petitioner").

Having the agency record before it, the Board finds, concludes and orders as follows:

1. August 1, 2006 Petitioner filed an Offer of Additional Evidence of Revocation of Licensees California Medical License and requested that Exhibit A attached to the offer be admitted into evidence to supplement the agency record.
2. On October 21<sup>st</sup>, 2006 an oral request was made by the Respondent and his attorney to submit additional evidence and exhibits for the record and that the Board should have an opportunity to review that additional evidence and exhibits prior to issuing its Final Order.

3. On October 21, 2006, the Board granted the requests of both parties to offer additional evidence.

4. On November 7, 2006 a CD containing documents and exhibits were submitted by Respondent and provided to all board members for review.

5. The Board finds that California has since reviewed the interim suspension issued on the Respondent's license and that the Respondent's license has been revoked in the state of California.

6. The Board adopts the findings of fact and conclusions of law as stated in the Initial Order, with the exception that the Board makes the additional finding that since the filing of the Initial Order, the Respondent's license in California has been revoked.


7. The Board adopts the decision of Presiding Officer, Steven E. Good that the license of Respondent should be revoked.

**IT IS, THEREFORE, ORDERED** that the license of Isaac Grillo, M.D. is hereby revoked.

**PLEASE TAKE FURTHER NOTICE** that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon the Board's Executive Director at 235 SW. Topeka Blvd., Topeka, KS 66603.


