COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about August 12, 2013, Stephen G. Grillot, D.O. (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee attend and successfully complete the Patient Care Documentation Seminar offered by the Center for Personalized Education for Physicians (“CPEP”). Further, Licensee was required to participate in and successfully complete the Personalized Implementation Program follow-up component of the Patient Care Documentation Seminar offered by CPEP.

2. On or about December 19, 2013, Licensee submitted to the Board documentation evidencing completion of “Patient Care Documentation Seminar” presented by CPEP on approximately December 6, 2013.

3. On or about August 13, 2014, Licensee submitted to the Board


documentation evidencing completion of “Personalized Implementation Program” presented by CPEP on approximately July 2, 2014.

4. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.


