SUMMARY ORDER

NOW, on this 18th day of November 2008, this matter comes before Jack Confer, Acting Executive Director of the Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and orders are made for and on behalf of the Board:


1. License number 16-01865 issued to Laura J Grotheer RT ("Licensee") to practice as a respiratory therapist in the state of Kansas expired on March 31, 2008, pursuant to K.A.R. 100-55-6.
2. On September 18, 2008, Summary Order 09-HA00019 was filed which found Licensee violated K.S.A. 65-5510(a)2 and was ordered a \$250.00 fine payable within 30 days of the effective date of the Summary Order.
3. Licensee failed to pay the \$250.00 fine within 30 days of the effective date of the Summary Order.
4. By failing to pay the \$250.00 fine within 30 days of the effective date of the Summary Order, Licensee has violated Summary Order 09-HA00019.

IT IS THEREFORE ORDERED that the license of Licensee issued by the Board to practice as a respiratory therapist in the state of Kansas is suspended on the effective date of this order.

PLEASE TAKE NOTICE that this is a summary order. A party to whom a summary order is issued may file a written request for a hearing within 15 days following service of the summary order. If a hearing is not requested, the summary order shall become effective as a final order of the Board upon expiration of the time for requesting a hearing.
