**ORDER GRANTING MOTION TO MODIFY STIPULATION  
AND AGREEMENT AND ENFORCEMENT ORDER**

NOW on this 8<sup>th</sup> day of April, 2000, this matter comes on for a conference hearing upon Petitioner's motion to modify the Stipulation and Agreement and Enforcement Order entered into with John R. Grow, M.D. Stacy L. Cook, Litigation Counsel for the Board, appears for Petitioner. Licensee does not appear in person, but has indicated in a letter addressed to the Executive Director for the Board and dated March 26, 2000 that he would not personally appear.

After reviewing the motion and being otherwise duly advised in the premises, the Board finds as follows:

1. A Stipulation and Agreement and Enforcement Order was entered into between the Board and Licensee on September 13, 1993.

2. The order required that Licensee enter into a monitoring contract, effective for five years, **Confidential** This monitoring contract expired on August 23, 1998.

3. On September 29, 1999, Licensee voluntarily entered into a five-year monitoring contract **Confidential** that will expire on September 29, 2004.

4. In his letter dated March 26, 2000, Licensee states that he does not object to this modification of the Stipulation and Agreement and Enforcement Order.

5. The order should be modified to require Licensee to comply with the monitoring contract **Confidential** effective until September 29, 2004.

**IT IS THEREFORE ORDERED AS FOLLOWS:**

A. That the findings here and above made be and the same are the Order of the Board.

B. The Stipulation and Agreement and Enforcement Order dated September 13, 1993 is modified to require Licensee to comply with the monitoring contract **Confidential** effective until September 29, 2004.

C. The remainder of the conditions, restrictions and limitations voluntarily stipulated in the Stipulation and Agreement and Enforcement Order dated September 13, 1993 remain unchanged.

**IT IS SO ORDERED.**
