ORDER GRANTING STATUS CHANGE

NOW on this 9th day of October, 1993, comes on for conference hearing before the Kansas State Board of Healing Arts (hereinafter "Board") sitting as a whole the request for waiver of continuing medical education requirements for completion of an application for status change from inactive to active filed by Mario L. Gumucio-Cardenas, M.D. (hereinafter "Applicant"). Applicant appears and participates in the proceeding.

After reviewing the application and being otherwise duly advised in the premises, the Board makes the following findings of fact:

1. Applicant was originally licensed to practice medicine and surgery in the State of Kansas October 7, 1967.
2. Applicant's license was cancelled August 20, 1991 due to Applicant's medical practice and professional activity in Cochabamba, Bolivia.
3. On November 6, 1992, Applicant's license was reinstated under inactive status. Applicant timely renewed his inactive license on June 9, 1993.

4. Applicant remained in Bolivia through September 19, 1993. Due to the unavailability of continuing medical education in Bolivia, Applicant has received only six of the required 50 hours of continuing medical education in the preceding year as required for active licensure by K.S.A. 65-2809 and K.A.R. 100-15-2.

5. By letter dated October 8, 1993, Applicant requested of the Board waiver of continuing medical education requirements necessary to change his license from inactive to active status.


**IT IS THEREFORE BY THE BOARD ORDERED** that Applicant's request for licensure status change from inactive to active should be granted and is effective October 11, 1993.

**IT IS FURTHER ORDERED** that Applicant must complete a minimum of 50 hours of continuing medical education, at least 20 of which shall be Category I, within 90 days of the effective date of this status change to maintain active licensure status.

**IT IS SO ORDERED.**


