FINAL ORDER

NOW, on this 12th day of March, 1994, this matter comes on for further consideration before the Kansas State Board of Healing Arts (hereafter "Board") relative to the **Request for Hearing** filed by Suresh Gurbani, M.D. (hereafter "Permittee") regarding the **Summary Order Cancelling Temporary Permit** issued by the Board on August 18, 1993.

The Board appears by and through Charlene K. Abbott, Licensing Administrator. Permittee appears in person.

After reviewing the file and being otherwise duly advised in the premises, the Board makes the following findings of fact and order:

1) Administrative notice is taken of all documents in the official agency file in the above-captioned matter involving Permittee.

2) The official agency record reflects that a **Summary Order Cancelling Temporary Permit** was issued pursuant to summary proceedings filed in the Board office and served on Permittee on August 18, 1993.

3) In the **Summary Order Cancelling Temporary Permit**, it was found and determined that the application for postgraduate training program permit, dated July 28, 1992, and submitted by Permittee met the qualifications for a temporary permit under the provision of K.S.A. 65-2811(a)(3) and as a result, Permittee was issued a temporary permit, T-240, effective August 17, 1992. Said temporary permit T-240 issued to Permittee expired by its own terms on August 17, 1993.

4) In the **Summary Order Cancelling Temporary Permit**, it was further found that Permittee had not submitted evidence necessary to qualify for a temporary permit under K.S.A. 65-2811(a)(2) nor had Permittee met the requirements for a permanent license to engage in the practice of medicine and surgery, pursuant to K.S.A. 65-2873.

5) On August 23, 1993, Permittee filed a timely request for a hearing on the **Summary Order Cancelling Temporary Permit** and said request was set for hearing on October 9, 1993.

6) At the hearing conducted October 9, 1993, the Board took the Request for Hearing under consideration and advisement and tabled the matter.

7) Since October 9, 1993, Permittee has passed Part 1 of the FLEX examination placing him in compliance with K.S.A. 65-2811(a)(2).

8) Based on changed circumstances while this matter has been under advisement, specifically the passing of the examination

to qualify Permittee for a temporary permit under K.S.A. 65-2811(a)(2), the Board hereby issues a temporary permit to Permittee pursuant to K.S.A. 65-2811(a)(2).

9) The Board further orders that temporary permit, T-240 issued August 17, 1992 was a good and valid temporary permit from August 17, 1992 until March 25, 1994, the date of issuance of temporary permit 94-03867 under the authority of K.S.A. 65-2811(a)(2).

IT IS THEREFORE ORDERED that findings here and above made by and are hereby made the orders of the Board.

IT IS FURTHER ORDERED that this is a final order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
