**PROPOSED DEFAULT ORDER REVOKING CERTIFICATE**

NOW on this 12th day of February, 2016, comes before the Kansas State Board of Healing Arts ("Board"), the Amended Petition for Discipline against Dorian Hall's, P.T.A.'s ("Certificate Holder") certificate to practice as a physical therapy assistant in the State of Kansas. Petitioner appears by and through Jane Weiler, Associate Litigation Counsel. Certificate Holder fails to appear.

Pursuant to the authority granted to the Board by K.S.A. 65-2901, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Proposed Default Order Revoking Certificate in the above-captioned matter. Having the agency record before it, and considering the evidence and the statements and arguments of Petitioner, the Board makes the following findings, conclusions and order:

1. Certificate Holder is or has been entitled to engage in the practice as a physical therapy assistant in the State of Kansas, having been issued Certificate No. 14-02897 on or about July 23, 2015, and having last renewed such certificate on or about January 8, 2016. Certificate Holder's certificate is currently active.

2. A conference hearing on the Board's amended petition for discipline was noticed

for February 12, 2016 at the offices of the Kansas State Board of Healing Arts.

3. Pursuant to K.S.A. 2015 Supp. 77-531, Certificate Holder was served with a Notice of Conference Hearing (“Notice”) to Certificate Holder’s last known mailing address via United States Mail, first-class postage prepared on or about January 22, 2016. The Notice was not returned.

4. Pursuant to K.S.A. 77-518, the Notice informed Certificate Holder that any party who fails to attend or participate in the Conference Hearing or other state of a proceeding may be held in default.

5. Certificate Holder failed to appear at the Conference Hearing held on February 12, 2016.


6. Pursuant to K.S.A. 77-518 and K.S.A. 2015 Supp. 77-520, Certificate Holder is in default for his failure to appear at the conference hearing on February 12, 2016.

7. Upon review of the agency record and after being fully advised in the premises, the Board finds and concludes that the facts and allegations set forth in the Amended Petition are undisputed and incorporated herein by reference.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that Certificate Holder is hereby held in DEFAULT pursuant to K.S.A. 2015 Supp. 77-520.

**IT IS FURTHER ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that Certificate Holder’s certificate to practice as a physical therapy assistant in the State of Kansas is hereby **REVOKED**.


