After examining the files, hearing statements of the Board counsel and being otherwise duly advised in the premises, the Board finds as follows:


- 1) That, Licensee remained in compliance with the **STIPULATION AND ENFORCEMENT ORDER** entered June 28, 1989.
- 2) That the **STIPULATION AND ENFORCEMENT ORDER** entered into on June 28, 1989 should be terminated.


