ORDER GRANTING SECOND TEMPORARY REGISTRATION

NOW on this 17th day of February, 1996, this matter comes on for conference proceedings before the full Board at the request of Tamra Sue Hammer (hereinafter "Registrant") to grant a second temporary registration pursuant to K.S.A. 65-5508(e).

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereinafter "Board"). Registrant does not appear. There are no other appearances.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. A request for second temporary registration was received from Respondent on January 22, 1996.
2. Notice of Conference Hearing setting this matter for hearing at 9:00 a.m. on February 17, 1995 was filed herein on February 2, 1996, and served on Registrant on that same date.
3. Registrant has applied for permanent registration as a respiratory therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5506(a)(3).

4. Registrant was granted temporary registration number 9501891, which expired January 17, 1996.

5. Pursuant to K.S.A. 65-5508(e), not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

6. Upon payment of the appropriate fees, Registrant should be granted a second temporary registration for the period from February 17, 1996 to August 17, 1996.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that upon payment of the appropriate fee, a second temporary registration be granted to registrant to expire on August 17, 1996.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
