**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 11<sup>th</sup> day of June, 2005, comes on for conference hearing before the Kansas State Board of Healing Arts ("Board") the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Jean-Michel Hassan, M.D. ("Applicant"). The Applicant did not appear. Charlene K. Abbott, Licensing Administrator, presented information to the Board

After reviewing the file, hearing the presentation made by Ms. Abbott, and being duly advised in the premises, the Board finds, concludes and orders as follows:

1. On April 1, 2005, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
2. As part of the Application, Applicant provided evidence that he received his medical degree from University of Paris XIII Medical School, France in 1980.
3. The University of Paris XIII Medical School is not an accredited medical school.
4. K.S.A. 65-2873(c)(2) provides that an applicant from a school that is not accredited may be granted a license if the applicant has completed three years of postgraduate training as approved by the Board.

5. The Board has adopted K.A.R. 100-6-2(b) that requires applicants who graduated from an unaccredited school of medicine to provide proof of completion of at least two years of postgraduate training approved by the council of education of the American Medical Association or its equivalent.

6. Applicant completed a one-year internship at Berkshire Medical Center, Massachusetts and spent 6 months in a residency program at Orlando Regional Medical School, Florida. Applicant also provided evidence of having been issued licenses in Alabama, Utah, Maryland, New York, New Mexico, Idaho, California and Washington and has been practicing in the United States since 1995.

7. While Applicant does not meet the requirements of K.A.R. 100-6-2(b), Applicant does meet the requirements of K.S.A. 65-2833 and is entitled to endorsement based on his licenses in eight other states.

**IT IS THEREFORE ORDERED** that the Applicant is eligible for endorsement and his Application for Licensure should be granted when presented to the Board for final action at its next regular meeting to be held August 13, 2005.


**IT IS FURTHER ORDERED** that temporary permit number 0526179 should be extended until August 13, 2005.

**PLEASE TAKE NOTICE** that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the

Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


