**EMERGENCY ORDER OF SUSPENSION AND
EMERGENCY PROCEEDINGS**

This matter came before the Presiding Officer on a Petition filed on January 10, 2020 on behalf of the Disciplinary Panel of the Board ("Petitioner"). Upon consideration of the agency record, including all filings and attached exhibits, the Presiding Officer finds, concludes and orders as follows:

1. Pursuant to K.S.A. 65-2838(c) and K.S.A. 77-536(c), that there is reasonable cause to believe that:

- a. grounds exist for disciplinary action; and
- b. the immediate continuation in practice by Randy D. Hassler, M.D. ("Licensee") would constitute an imminent danger to the public health and safety.

2. The cause to believe that grounds exist for disciplinary action and the Licensee's immediate continuation in practice would constitute an imminent danger to the public health and safety include the following:

- a. The facts set forth and incorporated in the Petition filed on January 10, 2020, and all such facts incorporated here by reference, including but not limited to two eye

witness allegations that Licensee sexually battered an unconscious patient.

- b. Licensee voluntarily surrendered his clinical privileges at Salina Regional Health Center ("SRHC").
 - c. Licensee is charged in Saline County District Court with Aggravated Sexual Battery and Rape of a Physically Powerless Victim. The criminal charges are pending.
3. Therefore, pursuant to K.S.A. 65-2838(c) and K.S.A. 77-536(b), Licensee's license to practice medicine and surgery is immediately temporarily suspended pending further proceedings and/or further Order of the Board.
 4. A notice of expedited hearing to determine whether the temporary limitation shall remain in place will be filed and served on all parties. If any party believes a different date or time should be designated for the expedited hearing, the party should notify the presiding officer immediately as described in the notice.

IT IS, THEREFORE, ORDERED that the license of Randy D. Hassler, M.D., is hereby **IMMEDIATELY SUSPENDED** as described above on a temporary basis pending a hearing to determine if there is adequate cause for the suspension to remain in effect.


