**SUMMARY ORDER OF CANCELLATION OF CERTIFICATION**

NOW, on this 12<sup>th</sup> day of September, 1997, this matter comes before Lawrence T. Buening, Jr., serving as Presiding Officer in summary proceedings. Joetta Woolery Hastings (hereinafter "Hastings") does not appear.

The Presiding Officer specifies the following findings of fact, conclusions of law and reasons for action:

1. K.A.R. 100-47-1, which was in effect on December 31, 1996, provided that as a condition for renewal for each odd numbered year, each registered Physical Therapist shall submit, in addition to the annual application for renewal of certification, evidence of satisfactory completion of a minimum of forty contact hours of continuing education during the preceding two year period.

2. On January 31, 1997, Hastings submitted an application for renewal of registration to the Kansas State Board of Healing Arts (hereinafter "Board") as a registered Physical Therapist for the period January 1, 1997 through December 31, 1997.

3. As part of the application for renewal, Hastings submitted request for an extension of time to obtain satisfactory completion of the required continuing education contact hours as

allowed by K.A.R. 100-47-1(b).

4. Hastings' request for an extension was granted for a period of six months through June 30, 1997 and Hastings' registration as a Physical Therapist was renewed through December 31, 1997.

5. Hastings has failed to provide evidence of satisfactory completion of a minimum of forty contact hours of continuing education and, therefore, has not met the conditions for renewal of her registration for the period ending December 31, 1997.

6. Hastings's certificate as a Physical Therapist should be cancelled due to failure to meet the requirements for renewal as set forth in K.A.R. 100-29-9 which became effective March 21, 1997.

**IT IS THEREFORE ORDERED** that the registration of Hastings issued by the Board as a Physical Therapist in the State of Kansas is cancelled.

**IT IS FURTHER ORDERED** that Hastings is entitled to request a hearing on this Order, in writing, to the Kansas State Board of Healing Arts, 235 S. Topeka Blvd., Topeka, KS 66603-3068 within five (5) days of service of this Order and if a hearing is not requested within the time and manner as stated above, this decision becomes final and effective upon the expiration of the time for requesting a hearing.
