ORDER EXTENDING POSTGRADUATE PERMIT

NOW, on this 14th day of December, 2002, comes on before the Kansas State Board of Healing Arts ("Board") for Conference Hearing the request made on behalf of Stephanie A. Haupt, M.D. ("Licensee") for modification of the effective dates of Postgraduate Permit Number 94-05199. Charlene K. Abbott, Licensing Administrator, presented information to the Board. There are no other appearances.

After hearing statements from Licensing Administrator and being duly advised in the premises, the Board finds and orders as follows:

1. Licensee was issued Postgraduate Permit Number 94-05199 under the provisions of K.S.A. 2001 Supp. 65-2811(b) and (c) to engage in the family medicine postgraduate training program at the University of Kansas Medical Center for the period July 1, 1999 through June 30, 2002.
2. Due to a medical leave of absence during the postgraduate training program, Licensee did not complete the postgraduate training program until August 26, 2002.
3. Licensee applied for a permanent license to practice medicine and surgery in the state of Kansas on March 19, 2002.

4. On July 26, 2002, Licensee's application for permanent license to practice medicine and surgery was deemed complete and Licensee was issued a Temporary Permit Number 0325280 under the provisions of K.S.A. 2001 Supp. 65-2811(a) effective July 26,2002.

5. Solely due to inadvertence and mistake, Licensee was without a permit or license to practice medicine and surgery for the period July 1, 2002 to July 26, 2002.


6. That Postgraduate Permit Number 94-05199 should be modified, extended and made effective from June 30, 2002 to July 26, 2002, the date Licensee was issued Temporary Permit Number 0325280 and the records of the Board modified to reflect such extension.

IT IS THEREFORE ORDERED that Postgraduate Permit Number 94-05199 originally effective for the period July 1, 1999 through June 30, 2002, is extended to be continuously effective to July 26, 2002.

IT IS SO ORDERED.


