**ORDER OF TERMINATION OF STIPULATION**

NOW, on this 19th day of October, 1996, comes for conference hearing before the full Board Licensee's request for termination of the Stipulation and Agreement and Enforcement Order filed August 1, 1994 ("Stipulation") between James E. Hays ("Licensee") and the Board of Healing Arts ("Board"). Lori Miskel McNett, Associate Counsel, appears on behalf of the Board. Licensee does not appear.

After hearing the recommendation of Associate Counsel and being duly advised in the premises, the Board makes the following findings of fact and conclusions of law and orders:

1. The Stipulation was entered into between Licensee and the Board on August 1, 1994.
2. Paragraph 10(e) of the Stipulation provides that the Board may entertain a motion to modify or terminate the Stipulation, provided certain requirements were met and Licensee did not violate any of the terms of the Stipulation. Licensee met said requirements and fully complied with the Stipulation.
3. By letter dated August 16, 1996 and filed with the Board on August 21, 1996, Licensee formally requested termination of the Stipulation.

4. Notice of Conference Hearing setting this matter for hearing at 10:30 a.m. on October 19, 1996 was filed herein and served on Licensee on October 3, 1996.

5. Counsel for the Board does not oppose the termination of said Stipulation.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that any and all restrictions and limitations placed on Licensee's license to practice medicine and surgery in the State of Kansas by the Stipulation and Agreement and Enforcement Order filed August 1, 1994 should be terminated and be of no further force or effect.


