**JOURNAL ENTRY OF SATISFACTION REINSTATING
ACTIVE LICENSE; EFFECTIVE JANUARY 22, 2019**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with K.S.A. 77-501, et seq, and upon due consideration of the agency record, applicable statutes and regulation, and being duly advised in the premises, makes the following determinations:

1. On October 16, 2018, the Board issued a Summary Order imposing the requirements therein. The Summary Order became effective as a Final Order on November 6, 2018.
2. The Summary Order, upon effectiveness as a Final Order, indefinitely suspended Jeffrey C. Hellinger, M.D.’s (Licensee) license until Licensee provided proof of professional liability insurance and payment of the premium surcharges required under K.S.A. 40-3404, *or* changed his license status to exempt or inactive.
3. Licensee did not change his license status to exempt or inactive.
4. On January 22, 2018 the Board received proof of professional liability insurance and payment of the premium surcharges required under K.S.A. 40-3404.
5. Therefore, Licensee was suspended from November 6, 2018, until January 22, 2019, when the Board received proof of professional liability insurance and payment of the premium surcharges required under K.S.A. 40-3404.

6. The Summary Order assessed a civil fine of \$500.00.
7. The Board received payment for the civil fine.
8. Licensee has met all requirements of the Summary Order and has no further obligation for compliance.
9. License is reinstated to Active status effective January 22, 2019

IT IS SO ORDERED.
