JOURNAL ENTRY OF SATISFACTION OF EDUCATIONAL REQUIREMENT AND FINE REQUIREMENT

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about October 17, 2013, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee to successfully complete ten (10) hours of additional continuing medical education credits specifically in the area of “Medical Record Keeping”, and to provide the Board documentation evidencing completion of the same by November 30, 2013. Further, Licensee was required to pay a fine in the amount of \$1000.00, which was due in full and payable to the Board by November 30, 2013.

2. The Board record reflects that, on or about September 26, 2013, Licensee made his fine payment of \$1000.00.

3. On or about September 26, 2013, Licensee submitted documentation evidencing


successful completion of ten (10) hours of additional continuing medical education credits specifically in the area of “Medical Record Keeping.”

4. The Consent Order’s requirement that Licensee enter into and comply with all terms and conditions of a monitoring contract with Affiliated Monitors, Inc. of Boston, Massachusetts for no less than one (1) year, remains in force and effect with the Board pursuant to the October 17, 2013 Consent Order.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from the educational requirement and the requirement to pay a fine as set forth in the Consent Order filed on October 17, 2013.
