FINAL ORDER GRANTING WITHDRAWAL OF APPLICATION

NOW on this 18^{th} day of January 2013, the Kansas State Board of Healing Arts ("Board") by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized Representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, and upon due consideration of the file and applicable statutes, and being otherwise duly advised in the premises makes the following determination upon Applicant's Request to Withdraw Application for Licensure, filed in the matter on November 27, 2012:

- On or about April 25, 2012, Applicant submitted an application for a license by endorsement to practice medicine and surgery in the State of Kansas. Such application was deemed complete and filed with the Board on November 13, 2012.
- On November 13, 2012, counsel for the Board filed a Response in Opposition to Applicant's application for licensure to practice medicine and surgery.
- 3. On November 14, 2012, the Board issued a Notice of Prehearing Conference to Applicant. The Notice of Prehearing Conference informed Applicant that a

Conference Hearing had been scheduled for Friday, December 7, 2012, at 10:00 a.m. and that he was requested to appear in person.

- 4. On November 19, 2012, counsel for the Board received a letter from Applicant, dated November 16, 2012, stating, "I appreciate the board's time and consideration. I will not be present Friday, December 7, 2012. I am officially withdrawing my application for a medical license in the state of Kansas."
- 5. On November 27, 2012, Respondent filed a Response in Opposition to Applicant's Request to Withdraw his Application for Licensure.
- 6. On or about December 5, 2012, Applicant, through his attorney, filed a Request for Continuance, seeking to continue the case until the next regularly scheduled Board meeting in February 2013.
- 7. On or about December 21, 2012, an Order of Continuance was issued, notifying the parties that the conference hearing scheduled for the December 7, 2012, Board meeting had been continued until February 8, 2013, at a time to be determined later.
- On January 11, 2013 Respondent withdrew its objection to Applicant's Request to Withdraw his Application for Licensure in Kansas.
- 9. The Board finds that because Respondent no longer objects to Applicant's request to withdraw his application for licensure to practice medicine and surgery in Kansas, it is appropriate to allow Applicant to withdraw his application.

IT IS THEREFORE ORDERED BY THE KANSAS STATE BOARD OF HEALING ARTS, that Applicant's request to withdraw from consideration his

application for licensure to practice medicine and surgery in the State of Kansas is hereby granted.
