After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations:

1. On September 25, 2007, the Executive Director, on behalf of the Board, issued a Summary Order in which it was determined that Kent Hoffman, P.A. ("Licensee"). be assessed a fine in the amount of \$100.00 for practicing as a physician assistant in the state of Kansas after his license was canceled.

2. On October 11, 2007, Licensee requested a hearing and the matter was scheduled for a conference hearing at 10:30 a.m. on Saturday, December 8, 2007.


3. On December 4, 2007, the Board received Licensee's request to withdraw his request for hearing and, therefore, the Summary Order became effective on December 4, 2007.

**IT IS THEREFORE DETERMINED** that License number 15-01028 is retroactively reinstated for the period January 1, 2007 until February 5, 2007, is considered to have been continuously on active status during such period of time, and the records of the Board be modified to reflect such retroactive reinstatement.

**IT IS FURTHER DETERMINED** that the assessed civil fine in the amount of \$100.00 be payable to the Kansas Board of Healing Arts and sent to Compliance Coordinator at the Board office on or before January 4, 2008.


