JOURNAL ENTRY

NOW, on this 26th day of November, 2007, the above-entitled matter comes on before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations:

1. On November 1, 2007, the Executive Director issued a Summary Order retroactively reinstating the license of C.R. Holbrook, III, M.D. ("Licensee") for the period July 1, through September 21, 2007, and assessing a civil fine in the amount of \$2,375 for Licensee's inadvertence, mistake or neglect for practicing medicine and surgery in the state of Kansas while his license was cancelled. The Summary Order was served on Licensee on November 5, 2007.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would become effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. On November 16, 2007, providing a check in the amount of \$2375 as payment in full for the civil fine assessed pursuant to the Summary Order.


4. By providing payment in full of the civil fine and not requesting a hearing within the time specified in the Summary Order, the Summary Order became effective on November 26, 2007.

IT IS THEREFORE DETERMINED that Licensee's license number 04-29380 should be retroactively reinstated for the period July 1, 2007 until September 21, 2007, be considered to have been continuously on active status during such period of time, and the records of the Board be modified to reflect such retroactive reinstatement.

IT IS FURTHER DETERMINED Licensee has paid in full the civil fine imposed in the amount of \$2375.



SUMMARY ORDER

NOW ON THIS 1st day of November, 2007, this matter comes before Lawrence T. Buening, Jr., Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of act, conclusions of law and order are made for and on behalf of the Board:

1. C.R. Holbrook, M.D. ("Licensee") was originally issued license number 04-29380 to practice medicine and surgery in the state of Kansas on October 20, 2001.
2. Licensee failed to renew his license for the period July 1, 2007 through June 30, 2008, prior to its expiration. Licensee's license expired June 30, 2007 and his license was canceled by the Board on August 1, 2007.
3. Licensee was sent a second renewal notice on July 10, 2007. On September 20, 2007 the Board received Licensee's renewal application and check #6409 totaling \$300.00 for reinstatement fees. Licensee's license was reinstated by the board on September 21, 2007.

4. By completion of Reinstatement of Canceled License form received September 25, 2007, Licensee requested retroactive reinstatement of his license back to July 1, 2007.

5. During the period July 1, 2007 to September 21, 2007 Licensee engaged in the practice of medicine and surgery in the state of Kansas.

6. Licensee said that he thought that he had renewed his license on-line, but apparently did not finish the process correctly. Licensee discovered that he had not renewed in a timely manner on September 3, 2007, when he called the Board to find out why he had not received his new wallet card and was told that he had been canceled for failure to renew. Licensee states that he did not discontinue practice after learning that his license had expired.

7. For his inadvertence, mistake or neglect for practicing medicine and surgery in the state of Kansas after his license was canceled, Licensee should be assessed a civil fine in the amount of \$2,375.00, to be payable within 30 days of the effective date of this order.

\$ 1,250	Practice after knowledge of cancellation
<u>(\$ 125)</u>	Credit for no prior history of license lapse
\$ 2,375	Total fine


IT IS, THEREFORE, ORDERED that license number 04-29380 should be retroactively reinstated for the period July 1, 2007 until September 21, 2007, be considered to have been continuously on active status during such period of time, and the records of the Board be modified to reflect such retroactive reinstatement.

IT IS FURTHER ORDERED that Licensee be assessed a civil fine in the amount of \$2,375.00, payable within 30 days of the effective date of this order, for his practice of medicine and surgery in the state of Kansas while his license was canceled.

PLEASE TAKE NOTICE that this is an Summary Order. A party to whom a Summary Order is issued may file a written request for a hearing within 15 days following service of the Summary Order. If a hearing is not requested, the Summary Order shall become effective as a Final Order of the Board upon expiration of the time for requesting a hearing. 
