SUMMARY ORDER CANCELLING TEMPORARY PERMIT

NOW, on this 15th day of August, 1992, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 1991 Supp. 77-538, the request submitted by Debra Lynn Holmes, M.D. (hereafter "Permittee") for an extension of her post graduate training permit. Permittee did not appear.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

- Permittee filed an application for postgraduate training program temporary permit with the Board dated May 7, 1991.
- As part of said application, it was certified that Permittee had been accepted as an intern or resident in the University of Kansas School of Medicine at Kansas City, Kansas, beginning June 24, 1991 in the Department of Psychiatry.
- At the time of submission of said application, Permittee had not provided proof of passage of FLEX as she was scheduled to FLEX I and II on June 16, 17 and 18, 1992.

- 4. Both Parts I and II of the examination are necessary to meet the examination in the basic and clinical sciences which has been approved by the Board and which constitutes a requirement for qualifications for a temporary permit pursuant to K.S.A. 1991 Supp. 65-2811(a)(2).
- 5. The application submitted by Permittee did not qualify her for a temporary permit under the provisions of K.S.A. 1991 Supp. 65-2811(a)(2).
- 6. The application submitted by Permittee met the qualifications for a temporary permit under the provisions of K.S.A. 1991 Supp. 65-2811(a)(3) and, as a result, Permittee was issued a temporary permit no. T-119 effective June 24, 1991.
- 7. Pursuant to K.S.A. 1991 Supp. 65-2811(a)(3), a temporary permit issued thereunder is valid for a period of one year following the date of issuance and no more than one temporary permit may be issued under said subsection to any person.
- 8. Pursuant to the statutory provisions of K.S.A. 1991 Supp. 65-2811(a)(3), temporary permit no. T-119 was issued to Permittee and effective June 24, 1991 expired on June 23, 1992.
- 9. Permittee did pass Part II of the FLEX but she failed Part I. Therefore, Permittee has not submitted evidence necessary to qualify for a temporary permit under K.S.A. 1991 Supp. 65-2811(a)(2), nor has she met the requirements for a permanent license pursuant to K.S.A. 65-2873.
- 10. Due to the statutory provisions of K.S.A. 1991 Supp. 65-2811(a)(3), temporary permit no. T-119 issued by the Board to

Permittee effective June 24, 1991 should be cancelled and be of no further force or effect.

IT IS THEREFORE ORDERED that temporary permit no. T-119 issued to Debra Lynn Holmes, M.D. effective June 24, 1991 is cancelled.

IT IS FURTHER ORDERED that Permittee is entitled to request a hearing on this Order, in writing, to the Kansas State Board of Healing Arts, 235 S. Topeka Blvd., Topeka, Kansas 66603-3068 within 15 days of service of this Order and if a hearing is not requested within the time and manner stated above, this decision becomes final and effective upon the expiration of the time for requesting a hearing.
