**JOURNAL ENTRY**

**NOW**, on this 10<sup>th</sup> day of July, 2008, this matter comes before Betty McBride, President of the Kansas Board of Healing Arts (“Board”). After having reviewed the agency record and being duly advised in the premises, the Board President makes the following findings:

1. On May 30, 2008, the Executive Director, on behalf of the Board’s Disciplinary Panel issued a Summary Order which ordered Andrew Holzmeister, R.T. to pay a \$50.00 fine for practicing respiratory therapy without a permit or license in violation of K.S.A. 65-5514(a) during the period of August 24, 2007 to May 20, 2008.
2. The Summary Order filed and mailed on May 30, 2008, contained a notice that it would become effective within fifteen (15) days following service if no request for a hearing was received by the Board prior to the effective date.
3. No hearing was requested Respondent; therefore, the Summary Order became effective on June 19, 2008.
4. The Summary Order required the \$50.00 fine to be paid to the Board on or before June 30, 2008. Licensee’s fine is past due and owing.

**IT IS, THEREFORE, DETERMINED** that the \$50.00 civil fine assessed against Andrew Holzmeister, R.T. shall be immediately paid to the “Kansas State Board of Healing Arts”.
