**FINAL ORDER DENYING LICENSURE BY ENDORSEMENT**

NOW on this 14th day of February, 2014, comes before the Kansas State Board of Healing Arts (“Board”) the application of Nurul Hoque, M.D. (“Applicant”) for a license to practice medicine and surgery in the State of Kansas. Applicant appears in person and *pro se*. Reese Hays, Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the evidence admitted, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. On or about January 14, 2014, Applicant submitted an application for a license by endorsement to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on January 15, 2014.
2. Applicant’s application seeks Kansas licensure by endorsement based on his medical licenses in New York and Georgia.
3. Applicant currently holds an institutional license to practice medicine in Kansas and has held such license and practiced in Kansas since approximately August 2008.

4. An institutional license is a restricted license which may be granted when applicants do not meet all of the requirements for a Kansas license by examination.


5. Applicant has not been actively practicing under his New York or Georgia licenses.

6. K.S.A. 65-2833(d) requires an applicant for licensure by endorsement to have “been actively engaged in practice” under their other state medical licenses since issuance in order to be granted a license.

7. Applicant does not meet the requirements of K.S.A. 65-2833 for licensure by endorsement in Kansas.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that Applicant’s application for licensure by endorsement in the State of Kansas is hereby DENIED. Applicant remains licensed under his Kansas institutional license.
