#### SUMMARY ORDER EXTENDING POSTGRADUATE PERMIT

**NOW,** on this 26<sup>th</sup> day of April 2003 comes on for Summary Proceedings before the Kansas State Board of Healing Arts ("Board") the request on behalf of Sarah Houssayni, M.D. for modification of the effective dates of Postgraduate Permit Number 94-05467. Lawrence T. Buening, Jr., Executive presents information to the Board. There are no other appearances.

After hearing statements from the Executive Director and being duly advised in the premises, the Board finds and orders as follows:

1. Sarah Houssayni, M.D. was issued Postgraduate Permit Number 94-05467 under the provisions of K.S.A. 65-2811(b) and (c) to engage in the pediatrics postgraduate training program at the University of Kansas School of Medicine-Wichita for the period January 1, 2001 through January 14, 2003.

2. Due to a medical leave of absence for nine months during the postgraduate training program, Dr. Houssayni will not complete her postgraduate training until January 14, 2004.

3. On April 22, 2003, the Board received the request that Dr. Houssayni's postgraduate permit be extended until January 14, 2004 and such permit was extended from April 23, 2003 through January 14, 2004.

4. Solely due to inadvertence and mistake, Dr. Houssayni was without a permit or license to practice medicine and surgery in the state of Kansas for the period January 15, 2003 to April 23, 2003.

5. Postgraduate Permit Number 94-05467 should be modified, extended and made effective from January 15, 2001 through January 14, 2003 and the records of the Board modified to reflect such extension.

IT IS THEREFORE ORDERED that Postgraduate Permit Number 94-05467 issued to Sarah I. Houssayni, M.D. originally effective for the period January 15, 2001 through January 14, 2003, is extended to be continuously effective from January 15, 2001 through January 14, 2004.
