**JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about October 14, 2013, Jeffrey S. Howell, D.C. (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee attend and successfully complete Board-approved continuing education courses in medical record documentation; coding and billing; and taking proper x-rays.

2. On or about January 3, 2014, Board Designee, Gary Counselman, D.C. approved the courses Diagnostic Imaging and Record Keeping offered by The Academy of Missouri Chiropractors to fulfill all of the continuing educational requirements of Licensee’s Consent Order.

3. On or about April 7, 2014, Licensee submitted to the Board documentation evidencing completion of Diagnostic Imaging and Record Keeping that was offered by The


Academy of Missouri Chiropractors on approximately April 4 through 6, 2014.

4. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.


