FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 10th day of December, 1993, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereinafter "Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the request submitted by Miriam K. Hunt, (hereinafter "Applicant") for waiver of Section 17 entitled "Certification of RT School" on the Application for Registration in Respiratory Therapy in the State of Kansas received September 30, 1993. Applicant did not appear.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

- 1. On September 30, 1993, Applicant filed an Application for Registration to practice respiratory therapy in the State of Kansas.
- 2. As part of that application, Applicant indicated that Section 17 of the application entitled "Certification of RT School" had not been completed since Applicant had not obtained formal classroom training in the field of respiratory therapy.
- 3. Although Applicant did not attend and complete a formal training program in respiratory therapy, she was certified on May 10, 1975 as a respiratory therapy technician by the National Board for Respiratory Therapy. In addition, she was registered in the State of Nebraska

from January 1987 until July 17, 1990 and has received the recommendation of the Kansas Respiratory Therapy Council for approval of her application without completion of Section 17.

4. The information provided by Applicant in support of the application is in substantial conformity with the requirements of K.S.A. 65-5508(b).

IT IS THEREFORE ORDERED as follows:

- A. That the findings here and above made be and the same are made the Order of the Board.
- B. Applicant has provided the information in substantial conformity with K.S.A. 65-5508(b) and she is entitled to endorsement.
- C. That Applicant's registration be granted at such time as she presents proof of current licensure or registration as a respiratory therapist in the State of Nebraska or other state with similar standards for licensure or registration.
- D. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service of this Order, file a Petition for Reconsideration. A Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
