## ORDER GRANTING SECOND TEMPORARY REGISTRATION

NOW on this 17th day of February, 1996, this matter comes on for summary proceedings under K.S.A. 77-537 at the request of Anita Huntley (hereafter "Registrant") to grant a second temporary registration pursuant to K.S.A. 65-2896d.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereafter "Board"). Registrant does not appear.

After hearing from the parties and Registrant and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

- 1. A request for a second temporary registration was received from Registrant on February 6, 1996.
- 2. This matter was submitted as an addition to the Board agenda and set for hearing at 9:00 a.m. on February 17, 1996.
- 3. Registrant has applied for permanent registration as a physician's assistant, but has not passed an exam approved by the Board as required by K.S.A. 65-2896(a)(3).
- 4. Registrant was granted temporary registration number 9620511, which expired on February 15, 1996.

5. Pursuant to K.S.A. 65-2896d, not more than one temporary registration shall be

permitted to any one person without the majority approval of the members of the Board.

6. The Board finds that sufficient cause exists to grant Registrant a second temporary

registration for the period of February 15, 1996 to December 17, 1996.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that upon payment of

the appropriate fee, a second temporary registration be granted, to expire on December 17,

1996.

IT IS FURTHER ORDERED that this is a final order and is effective on service upon

the parties. Any party may, within fifteen (15) days of service, file a Petition for

Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking

administrative or judicial review.

IT IS SO ORDERED.
