FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 31st day of January, 2004, comes on for Conference Hearing before the Kansas State Board of Healing Arts ("Board") the Application for Licensure to practice chiropractic in the state of Kansas filed by Mary A. Huss, D.C. ("Applicant").

Charlene K. Abbott, Licensing Administrator, presented information before the Board. Applicant appeared in person *pro se*.

After reviewing the file, hearing the statements of Ms. Abbott and Applicant and being otherwise duly advised in the premises, the Board finds and orders as follows:

1. On November 6, 2003, Applicant filed an Application for Licensure to receive a license to practice chiropractic in the state of Kansas.
2. Applicant has not passed the examinations required by the Board to obtain a license by examination under K.S.A. 65-2873.
3. As part of the Application, Applicant provided evidence that she was licensed to practice chiropractic in the state of Missouri on July 13, 1983, and such license remains valid and active and has never been limited, suspended or revoked nor has Applicant ever been censured or had other disciplinary action taken by the Missouri Board of Chiropractic Examiners.

4. To receive the license to practice in the state of Missouri, Applicant passed a state examination administered by the Missouri Board of Chiropractic Examiners.

5. Applicant has continuously practiced chiropractic in the state of Missouri from and since November 1983.


6. The state examination administered by the Missouri Board of Chiropractic Examiners was equal in quality to that required by the state of Kansas and the passing grade required by the state of Missouri was comparable to that required by the Board.

7. Applicant meets the requirements for license by endorsement under the provisions of K.S.A. 65-2833

IT IS THEREFORE ORDERED that the above findings are made the order of the Board and that Applicant is eligible for a license to practice chiropractic under the provisions of K.S.A. 65-2833.


