NOW, on this 12th day of June, 1993, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the request submitted by Donald M. Hutchin, R.T., (hereafter "Registrant") for waiver of Section 17 entitled "Certification of RT School" on the application for registration in respiratory therapy in the state of Kansas received April 28, 1993. Applicant did not appear.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. On April 28, 1993, Registrant filed an application for registration to practice respiratory therapy in the state of Kansas.

2. As part of that application, Registrant indicated that Section 17 of the application entitled "Certification of RT School" had not been completed since Registrant had not obtained formal classroom training in the field of respiratory therapy. 3. Although Registrant did not attend and complete a formal training program in respiratory therapy, he currently holds a active and valid registration in the state of Missouri. In addition, he has been in actively working in the field of respiratory therapy for an excess of 15 years and has received the endorsement of the Kansas Respiratory Therapy Council for approval of his application without completion of Section 17.

4. The information provided by Registrant in support of the application is in substantial conformity with the requirements of K.S.A. 65-5508 and the Board waives the educational requirements under subsection (b) of said statute.

IT IS THEREFORE ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. Registrant has provided the information in substantial conformity with K.S.A. 65-5508 and he is entitled to endorsement without meeting the education requirements pursuant to subsection (b) of said statute.

C. That Registrant's registration be granted upon service of this Order upon the parties.

D. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service file a petition to review this order within fifteen days after service of this Order file a Petition for Reconsideration. A Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review. IT IS SO ORDERED.
