**ORDER MODIFYING STIPULATION AND
AGREEMENT AND ENFORCEMENT ORDER**

COMES ON NOW for Conference hearing before the Board of Healing Arts on this 12th day of August, 1995, the matter of the Application for Modification of Stipulation by Dr. Marc Hutchison. The Board appears by Shelly Gasper, Acting Associate Counsel. Licensee appears in person and by counsel, Reid F. Holbrook. (confidential) is present to answer questions.

After consideration of the application, the original Stipulation and Agreement and Enforcement Order, the monitoring reports and suggestions of counsel,

IT IS ORDERED, ADJUDGED AND DECREED that:

1. Licensee is no longer required to be under the supervision of a physician while performing services within the scope of his employment at St. Luke's Occupational Medicine Health System. Further, St. Luke's Occupational Medicine is no longer required to report quarterly on Licensee's actions as specified in the Stipulation at paragraph 9, subsection (e).

2. Licensee is no longer restricted from prescribing Class II, Class III and Class IV narcotics.



3. The remaining requirements of the Stipulation will remain in effect.

4. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration, stating the specific grounds upon which relief is requested. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.


